**POLICY GUIDELINES FOR NAMES ON THE MEMORIAL ADOPTED JANUARY 24, 2000**

1. Male & Female Veterans may qualify to have their name added to the Chatham Veteran's Memorial. There will be no restrictions for residency on veterans. This general policy is an attempt to be inclusive rather than exclusive for determining names on the Veteran's Memorial.
2. A man or woman must hold an honorable discharge or a discharge under honorable conditions to qualify for a name to be added to the memorial, such as medical, family emergency, etc.
  - 2a. If such person subsequently is discovered to have had a less than an honorable discharge, his/her name shall be removed immediately, no refund will be given and additional charges for removal may be charged.
3. Individuals serving more than one enlistment or branch of the Armed Forces of the United States of America, the last enlistment must meet the same qualifications as stated in item #2.
4. After the initial installation of bricks, 50 bricks at a time will be added to the Veteran's Memorial.
